SECOND DECLARATION OF SHELLEY M. DAHL IN SUPPORT OF PLAINTIFFS' AMENDED MOTION FOR SUMMARY JUDGMENT IN PRESBYTERY II

- I, Shelley M. Dahl, pursuant to RCW 9A.72.085, declare as follow:
- 1. I am a Ruling Elder at University Presbyterian Church, a member of the Presbytery of Seattle (the "Presbytery"), and co-moderator of the Administrative Commission for First Presbyterian Church of Seattle ("FPCS"). I have personal knowledge of the matters set forth in this declaration and am competent to testify about those matters.
- 2. The Declaration of Jeff Schulz submitted in opposition to plaintiffs' amended motion for summary judgment refers to a letter dated September 21, 2014, that

he sent to Seattle Presbytery representatives. I was one of those representatives. Attached as **Exhibit A** is a true copy of the email that Jeff Schulz sent to me and others at the end of the day on September 24, 2014, attaching the letter dated September 21.

- 3. The September 21 letter refers to a decision by the FPCS Session to retain Louisiana lawyer Lloyd Lunceford. The letter asserts, and the Declaration of Jeff Schulz repeats, that Mr. Lunceford was hired to update the church's corporate documents. Jeff Schulz goes on to declare that the "Session did not hire Mr. Lunceford to advise the Session regarding disaffiliation or 'misappropriation' of church property."
- 4. Mr. Lunceford is well known as a lawyer who represents churches trying to break denominational ties and to leave with church property. He is a co-author and the general editor of *A Guide to Church Property Law* (2d ed. 2010).
- 5. On September 29, 2014, Mr. Lunceford sent Jeff Schulz draft severance agreements. Mr. Lunceford's cover email stated:

As per your request attached are draft severance packages for you and your wife, for consideration by the session for adoption. They are in the form of amendments to your current terms of call and contain other provisions intended to increase the probability that they will constitute protected property rights that could not be taken away without due process of law. . . . The document also provides that it is irrevocable except for Good Cause, as defined.

6. I know about this email because then-FPCS elder Neal Lampi forwarded it to Kevin Nolette, associate executive presbyter for Seattle Presbytery. Mr. Lampi had received Mr. Lunceford's message from Jeff Schulz with a cover note clarifying that David Martin, a member of the FPCS session, had asked Mr. Lunceford to prepare the severance agreements, not Jeff. Jeff Schulz also suggested "that Session talk about this verbally rather than by email." This email string is attached as **Exhibit B**.

- 7. Kevin Nolette replied to Neal Lampi on October 4, 2014, noting that "all Terms of Call are subject to congregational approval and presbytery approval." When the Schulzes actually signed severance agreements in November 2015, those agreements were not approved by the congregation or the presbytery.
- 8. Attached as **Exhibit C** are true copies of the draft severance agreements that Mr. Lunceford sent to Jeff Schulz on September 29, 2014.
- 9. In September 2014 the Presbytery's Committee on Ministry asked the FPCS session to produce, among other things, the minutes of the Board of Trustees of FPCS. Ellen and Jeff Schulz (in consultation with the FPCS session) responded as follows: "The Board of Trustees was disbanded prior to Jeff and Ellen's arrival (Jan 2006). At that time, the Trustees were merged into Session." See **Exhibit A**, p. 2. The Schulzes went on to say that they planned to reinstate the Board of Trustees "to take the corporate/property development piece off of Session's plate."

Some of those additional records (referenced in the documents you've already provided) are:

• a proposal written by Jeff to Tim and Tyler of a model of practical matters such as leadership and function. That was the idea, but it turned out that after talking to Scott Lumsden we sent an initial email to COM.

- a letter Jeff prepared to the principal leaders of A Seattle Church with suggestions on how to do ministry together. This was an initial attempt to write down what we understood to be "joint ministry," following up on our March 25 meeting with Kevin & Colleen. We ended up meeting together to discuss it.
- the summary from a meeting with a branding group to discuss ideas for logos and designs for the joint ministry. We don't have a digital copy of logo idea, but it's a basically the same tower logo we have now integrated into an image of one of our stained-glass windows. Will either get a digital copy or bring one to our meeting.

Here is the summary, which is just bullets from a conversation:

- · That people experience God's love. They love God and love others.
  - the assessment done by Collaborative of the sanctuary as worship space for the expanded group of worshippers. This was an informal visit by some friends at Collaborative, resulting in their thoughts repossible approaches to potential adjustments/upgrades to audio/video in the sanctuary.
  - the compiled stories of both SFPC and A Seattle Church in anticipation of you coming together in October of this year. That's the "pastoral letter" we already sent that was shared in worship on Aug 24.
    - 2) to receive and review the minutes of all session and congregation meetings from January 2013 through Feb 2014, including the minutes of the Board of Trustees from January 2013 to present and its membership/roster of officers. Additionally, to receive and review the current and former bylaws of SFPC and the current and former Articles of Incorporation of SFPC. Most of this will have to wait for our clerk's return. The Board of Trustees was disbanded prior to Jeff and Ellen's arrival (Jan 2006.) At that time, the Trustees were merged into Session. As the minutes say, we're reinstating them to take the corporate/property development piece off of Session's plate.

As far as written plans we just don't have anything like that. What's happening is based on relationships and conversation. As we have long said, we would love to share the story with you and answer whatever questions you have.

Attached you will find our minutes from January, 2013 through January, 2014.

In recent conversations with COM and Presbytery representatives, it has become clear to us that there are numerous potential misunderstandings and inaccuracies being circulated about the SFPC Session's intentions related to our denominational affiliation, SFPC property/assets, legal counsel and the coming together with the people of "A Seattle Church."

Like most other PC(USA) Sessions, for several months our Session discussed denominational developments, our disposition on them, and considered getting more information about the discernment process, all of which we shared with Scott Lumsden in December. As our minutes clearly show, the conversation went no further than December, which we shared with Scott Lumsden as well. Session agreed that regardless of preceding GA decisions on ordination, and the upcoming decision on marriage, that we continued to feel free to fulfill our mission in PC(USA) and were thankful for a healthy and gracious Presbytery in which to do ministry.

As our January minutes show, we made a point of communicating where the Session was on this to Tim Gaydos and Tyler Gorseline.

As our February minutes show, subsequent Session conversation on denominational issues was about how to shepherd our congregation up to and through the General Assembly decisions on marriage, divestiture, and other key issues.

In summary, as our minutes show, and as has been clarified in recent conversations with COM/Presbytery representatives, SFPC Session has had no further conversation about denominational issues.

It has also been brought to our attention that the securing of Lloyd Lunceford to review our corporate documents raised questions about the Session's intentions related to denominational affiliation and property. Again, as our minutes show, and as has been clarified in recent conversations with COM/Presbytery representatives, we retained Lloyd for the purpose of reviewing/updating our corporate documents. As we had previously realized, the property development process reminded us of the need to update them, and to re-establish the trustees to handle property development issues. Given the number of ways in which our present legal counsel was already involved in numerous matters related to SFPC, Session preferred to retain other counsel.

Jeff Schulz called one of the people with whom he typically consults on administrative/legal matters, Mark Story, Executive Director of Highland Park Presbyterian, where Jeff and Ellen served before coming to Seattle. Mark Story recommended consulting with HPPC lawyer, Lloyd Lunceford. Lloyd offered some initial pro bono advice on how to proceed, and we subsequently retained him to review and update our corporate documents as needed. These revisions are for the purpose of updating how we operate as a congregation and re-establishing our trustees.
